

JOLLY JACKPOT 2018 OFFICIAL SWEEPSTAKES RULES

1. Sponsorship. This sweepstakes is sponsored by AWESOME HAND SERVICES, LLC ("AHS"), and fifty-three (53) participating AHS Locations listed in Appendix A (each a "Participating Location" and together with AHS, the "Sponsors"). AHS's principal place of business is located at 1151 Rohlwing Road, Rolling Meadows, Illinois 60008. The Participating AHS Locations' principal places of business are also listed in Appendix A (collectively, "Sponsors' Locations").

2. Sweepstakes Procedure. Beginning on December 1, 2018, during the Entry Period (as herein defined), Participants may enter the promotion through a Data Form Entry or a Facebook Entry, as set forth below. Each person who enters the promotion via a Data Form Entry or a Facebook Entry is referred to herein as a "Participant". Each Data Form Entry must include the Participant's: (a) first and last name, (b) primary telephone number, (c) email address, (d) home address, (e) entry date, and (f) date of birth (subparts (a) through (f) are herein referred to as the "Required Participant Information"). The Required Participant Information must be accurate and current as of the date of the entry. A Participant is permitted one entry per day per Participating AHS Location via a Data Form Entry. A Participant is permitted one entry per day via Facebook Entry. In the event that a Participant fails to comply with any of the requirements contained in this Section or that are otherwise provided for herein, at the sole determination of the Sponsors, such Participant may be disqualified from the JOLLY JACKPOT 2018 SWEEPSTAKES. Moreover, at the sole determination of the Sponsor, all of that Participant's entries may be deemed null and void, not honored or acknowledged and may be grounds for forfeiture of his/her prizes.

DATA FORM ENTRY: Participants may enter the promotion via a Data Form Entry if they find the hidden paper holiday gnome in any of the Participating AHS Locations' gaming area and bring the holiday gnome to any employee of that location that is currently on duty. The individual will then receive a data form on which they will write the Required Data Participant Information which will be dropped into the ballot box upon completion. Data Form Entries will be accepted during normal business hours of each Participating AHS Location between December 1, 2018, and December 25, 2018 (the "Entry Period").

FACEBOOK ENTRY: Participants may enter the promotion via Facebook Entry if they find the hidden paper holiday gnome in any of the Participating AHS Locations' gaming area and message Awesome Hand Gaming a photo of the Participant with the hidden paper holiday gnome via Facebook Messenger along with the Required Participant Information. Facebook Entries will be accepted during normal business hours of each Participating AHS Locations during the Entry Period, and will be combined with the Data Form Entries for purposes of the drawing described below. Any Entry received after business hours will be treated as if received on the next business day.

3. NO PURCHASE IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. FURTHER, A PURCHASE (INCLUDING, WITHOUT LIMITATION, PLAY OF VIDEO GAMING TERMINALS OR THE PURCHASE OF ANY PRODUCT, GOOD OR SERVICE SOLD BY ANY SPONSOR) WILL NOT IMPROVE A PARTICIPANT'S CHANCES OF WINNING A PRIZE IN THE SWEEPSTAKES.

4. Drawings. The drawing will occur at AHS's marketing office at 3:00pm on January 4, 2018 (the "Drawing Date"). An employee of the AHS marketing team will conduct the drawing. The first Entry drawn at random from the eligible entries on the Drawing Date will win an Eight Thousand Dollar (\$8,000.00) check, provided by Awesome Hand Services, LLC. The second Entry drawn will win a One Thousand Dollar (\$1,000.00) check, provided by Awesome Hand Services, LLC. The third and fourth Entry drawn will win a Five Hundred Dollar (\$500.00) Visa Gift Card. The fifth, sixth, seventh, eighth, ninth, and tenth Entry drawn will win a One Hundred Dollar (\$100.00) Visa Gift Card. Winners need not be present to win, but must be available for contact via phone, email, or Facebook message within 72 hours of the drawing. In the event a winner is not available for contact, he/she will forfeit his/her prize and an alternative winner may be selected by random drawing.

5. Prizes, Prize Values, Odds of Winning and Collecting Prizes.

(a) By entering this promotion, Participants are eligible to win up to Ten Thousand Six Hundred Dollars (\$10,600) in the form of check and/or Visa Gift Card(s). It is the Participant's responsibility to read and

understand all information, if any, which accompanies any prize concerning use, risks, and maintenance. No winner may substitute his/her prize.

- (b) All costs and expenses associated with a Participant's acceptance and use of a prize not specified herein as being provided as part of the prize are the sole responsibility of the winning Participant. - (e) The winner of the Eight Thousand Dollar (\$8,000.00) check and the One Thousand Dollar (\$1,000.00) check will be contacted via phone, email, or Facebook messenger on the Drawing Date. At that time, AHS and the winning Participant will arrange a date and time within seven (7) business days of the Drawing Date for the Prize Information to be collected and the check to be delivered to the winning Participant. The meeting place will be either at the Participating Location where the winning Participant entered or at AHS's principal place of business. Failure to meet the representative of AHS at the agreed place/time will result in the prize being forfeited. The winning Participant is responsible for all transportation costs to meet at the agreed pick-up location. There are no shipping or handling fees associated with collecting the prize.
- (f) The winners of the Five Hundred Dollar (\$500.00) Visa Gift Card and the One Hundred Dollar (\$100.00) Visa Gift Card will be contacted via phone, email, or Facebook messenger on the Drawing Date. The prizes will be sent to the winners by U.S. mail within (14) days, postage pre-paid, after the winner(s) have been notified. If the prize is returned as undeliverable, then the prize will be forfeited. There are no shipping or handling fees associated with collecting the prize.

6. Eligibility. This sweepstakes is open to all legal residents of the United States of America who are twenty-one (21) years or older at the time of entry. As applicable, owners of the Sponsors, employees of the Sponsors, their affiliates, licensees, franchisees, advertising and promotional agencies and the immediate family members of each are not eligible. An "immediate family member" is defined to mean spouse, parent, grandparent, child or sibling. In-laws are not considered to be immediate family members.
